

# Campaign To 'Drive Out Hunger' Is Going Strong

The Hardee Help Center's Drive Out Hunger Campaign is well underway, and community participation has been outstanding.

Food donation bins have been disbursed throughout Hardee County including many of the schools and 4-H clubs.

Schools participating this year are: Bowling Green Elementary Student Council, Zolfo Springs Elementary, North Wauchula Elementary fourth- and fifth-grade National Honor Society, Wauchula Elementary, Hardee Junior High Student Council, Hardee Homeschool Co-op, and AVID & Key Club of Hardee Senior High.

4-H clubs participating this year are: Cracker Trail and Fort Green. According to the Florida

Department of Education Bureau of Student Assistance 2013, there are 128 homeless children in Hardee County. Food insecurity and hunger stem from poverty and a lack of reliable income sources, making the homeless population the most vulnerable.

"To see our schools participate in an effort to collect food donations from children and families that will possibly be recipients of the food as well, proves that anyone can be a Hunger Hero," states Hardee Help Center Director Jamie Samuels.

Being a "Hunger Hero" does not require a lot of money, but often requires additional planning. One way that families can be Hunger Heroes and help pre-

pare for unexpected situations is by building two emergency food boxes, one for their family and one for another family in need. This simple step of preparation can prevent families from going hungry during emergency situations.

The center's Drive Out Hunger Food Pantry is another resource for families in need during an emergency situation.

Some examples of reasons for assistance are forced displacement, recent layoff, shortage of work hours, short-term medical emergencies, and placement of other relative's children in the home.

As the food donations pour in from the public during the month of November, the Hardee Help Center is asking for people

to consider volunteering their time in the Drive Out Hunger Food Pantry located at 713 E. Bay St. in Wauchula. The scheduled food sorting dates for volunteers are: Monday, Nov. 16, 2-5 p.m. and Monday, Nov. 30, 10 a.m. to noon.

The '70s - Nov. 13, 1975

40 Years Ago

New Elementary: The School Board will open bids for the new elementary school north of Wauchula, which is expected to cost about \$1.5 million, including utilities and paving. The 822-student school will be built on the 13.4-acre site the board bought from Dewey Waters over a year ago for \$50,000.

With construction time of 280 calendar days, it should be ready for the 1976-77 school term. The school will have a semi-open concept, with 32 classrooms divided into eight sections of four classes each and an activity space.

**Football War:** "It's going to be a war!" said Hardee football coach Jerry Kapusta of Friday night's game against 7-1 Palmetto, which is coming off a hard-hitting 14-7 overtime loss at Venice. The Wildcats, also 7-1, are coming off a five-game win streak in which they have racked up 225 points while only giving up 21.

Quarterback Mike McCrary, who was out last week at Florida Air Academy, will again be replaced by Steve Shumard. Running back Lee Revell is also out and will be replaced by Myron Refoure, who came up from the JV when its season ended last week. Tank Snelling and Freddie Snelling are the key running backs. Hardee beat Florida Air Academy 60-0.

**Tax Watchers:** The just-formed Hardee County Property Owners Association has 21 charter members. Its function is to watch local government spend-

ing, especially property tax dollars. The group has incorporated, with Joe L. Davis, president; Ray Wingate, vice president; Tommy Underwood, secretary; and Bill Crews, treasurer.

Dues are a minimum of \$25 a year, based on a person's property taxes.
